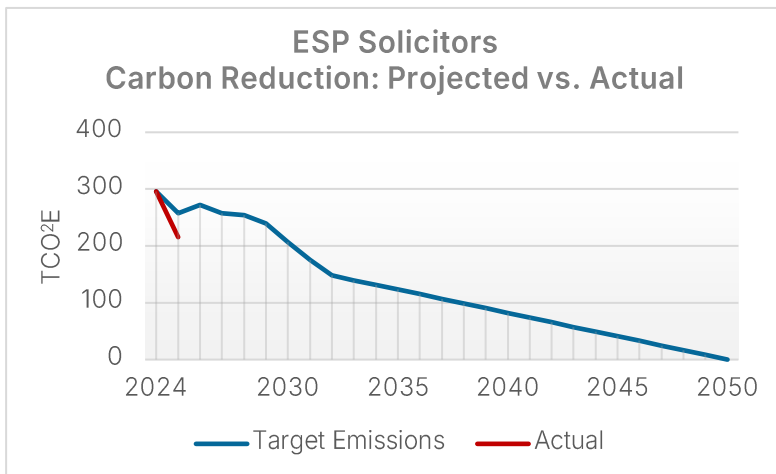

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- **We project that carbon emissions will decrease over the next six years to 147.97 tCO₂e by 2032. This is a reduction of 50%.**
- **We aim to achieve net zero by 2050.**

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline. The carbon emission reduction achieved by these schemes equate to 80.5 tCO₂e, a **27% reduction against the 2024** baseline and the measures will be in effect when performing the contract.

- Board approved net zero targets set and ESG policies agreed
- Colleague survey & education on commuting behaviours
- Review of top ten suppliers carbon usage
- Sustainable choices for business travel

Future carbon reduction initiatives

In the future we intend to implement further measures including:

- Switch to green electricity in line with group policy
- All future company cars will be EVs in line with group policy
- Extension of EV benefit scheme to cover further employees
- Group's Sustainable Property Criteria will apply to any future office move or new lease
- Supplier consolidation and vetting to include ESG criteria


This Carbon Reduction Plan has been completed in accordance with PPN 006 and associated guidance and reporting standard for Carbon Reduction Plans.
